8 9 10	Whereas, in 2017, there are more than 47,800,000 individuals age 65 or older in the United States, and those individuals account for 14.9 percent of the total population of the United States;
l1	Whereas approximately 10,000 individuals in the United States turn age 65 each day;
L2	Whereas, in 2015, more than 9,300,000 veterans of the Armed Forces were age 65 or older;
13 14 15 16	Whereas older individuals in the United States rely on Federal programs, such as programs under the Social Security Act (42 U.S.C. 301 et seq.) (including the Medicare program under title XVIII of that Act (42 U.S.C. 1395 et seq.) and the Medicaid program under title XIX of that Act (42 U.S.C. 1396 et seq.)), for financial security and high-quality affordable health care;
L7 L8 L9	Whereas the Older Americans Act of 1965 (42 U.S.C. 3001 et seq.) provides supportive services to help individuals of the United States who are age 60 or older maintain maximum independence in the homes and communities of those individuals;
20 21 22	Whereas that Act provides funding for programs, including nutrition services, transportation, and care management, to assist more than 11,000,000 older individuals in the United States each year;
